### **Rates May Be Changing in 2015**

### **30-Day Comment Period**

You may submit written comments on the proposed rate changes within 30 days of the rates being submitted to the Department's review. **If you are interested in submitting comments, you must do so no later than [December 26, 2014].** All submitted comments will be posted on the Department of Financial Services website with personal identifying information removed.
